All room reservations including the hospitality suites must be made with the MSA Secretary Treasurer. Rooms and special room requests will be assigned in the order the registrations are received. MSA has a total of 130 rooms available. Each Temple is required to provide a credit card to secure their own rooms and to pay on checkout.

Standard rooms \$114.34 (single or double) MSA has reserved 2 Board Rooms as Hospitality Suites for 5 Temples to share which are located close together on the main floor. If the Temple wants their own Hospitality Room they can use a guest room on the main floor at \$114.35/night, but furniture must stay in the room.
